CJAB Fact – Cross-system collaboration between Human Services and the Criminal Justice System grew substantially through the 2000's. Formalized practices in Adult Criminal Court began to advance in earnest with programming such as Drug Court and Veterans Court in 2008 and 2012, respectively. Each program includes a multidisciplinary Treatment Team, comprised of staff from CJAB member departments. The Courts were and are vital in supporting these programs while adjusting to the unique needs and challenges of each participant. Recent data from 2022 indicate that, even a few years after graduation, only about 15% of those who have successfully completed Drug Court since 2018 have received new charges. This is a striking success, as these programs focus on individuals with complex criminal histories and treatment needs. Combined, Veterans and Drug Court have graduated more than 221 individuals. Mental Health Court will add more success to those ranks in the coming months.
