<u>GENERAL</u>

The purpose of this packet is to assist a **DEFENDANT** who wants to request a change to a Final Protection Order that has been entered by the Court. The Final Protection Order can be a result from the following:

- Final Protection from Abuse Order
- Final Protection from Sexual Violence Order
- Final Protection from Intimidation Order

A party may seek to modify any of the provisions contained in the final order, including the date that the order will end.

This packet is only for Defendants to Modify a Final Protection Order. If you are the Plaintiff, do not file this form but contact the Victim Witness Office at (717) 780-7077.

If there is a health and safety issue involving the child(ren), a parent or anyone who has a claim for custody may file an Emergency Petition for Special Relief along with the Custody Complaint or a Petition for Modification of an Existing Custody Order or a Petition for Contempt of an Existing Custody Order.

FILING INSTRUCTIONS AND PROCEDURAL INFORMATION

Please read these instructions carefully. If you do not complete the forms correctly, and file and serve them correctly, the Court may not be able to hold a hearing which means your request to modify your order will be delayed.

- 1. Fill out the following forms contained in this packet.
 - Scheduling Order Complete the Caption (Plaintiff/Defendant located in the top left-hand corner) as it appears on your Final Protection Order. Do not complete anything else on the scheduling order.
 - Defendant's Petition to Modify a Final Protection Order -- Complete the
 Caption (Plaintiff/Defendant located in the top left-hand corner) as it appears on
 your Final Protection Order. Check the appropriate box as to the type of
 Protection Order you are seeking to modify. (Paragraph 1) You are the petitioner
 since you are filing the petition. If your address is confidential, check the
 appropriate box and complete the Confidential Information Form Abuse Victim

Addendum. (Paragraph 2) Enter the date of the Final Protection Order and name of the Judge. (Paragraph 3) Enter the expiration date of the Final Protection Order. (Paragraph 4) Write how you would like the order to be modified and (Paragraph 5) the reasons why you would like the order modified.

 Affidavit of Service -- Complete the Caption (Plaintiff/Defendant located in the top left-hand corner) as it appears on your Final Protection Order. You must send a copy of the Defendant's Petition to Modify Final Protection Order addressed as follows:

 Order -- Complete the Caption (Plaintiff/Defendant located in the top left-hand corner) as it appears on your Final Protection Order. Do not complete anything else on the scheduling order.

If you print out the packet from the Self-Help Center page of the Dauphin County website, the Confidential Information Form and the Confidential Information Form Abuse Victim Addendum are not included. You must print out these forms in accordance with the instructions appearing on the webpage.

2. You must make at least three (3) copies of the completed forms and take them to the Prothonotary's Office which is located on the first floor of the courthouse. The Prothonotary's Office will time stamp these forms and will keep the original and one copy. The clerk will give two copies back to you. One copy is for you to keep, and the other copy is for you to serve as follows:

The original will be taken by the Prothonotary clerk to the Court Administrator's Office. The Court Administrator's Office will take the petition to a judge. You will receive the scheduling order in the mail from the judge's office.
