A temporary guardian may be appointed by the Court for a limited period for a minor when the minor's custodial parent has entered a rehabilitation facility for treatment of drug or alcohol addiction or has been subject to emergency medical intervention due to abuse of drugs or alcohol.

### Only a grandparent, aunt, uncle or adult sibling of the minor child(ren) is permitted to serve as a temporary guardian.

The custodial parent may designate the family member as a temporary guardian by completing the Designation of Temporary Guardian form. However, if the custodial parent has not designated a temporary guardian, the proposed temporary guardian should use the forms contained in this packet.

## INSTRUCTIONS FOR COMPLETING THE PETITION FOR TEMPORARY GUARDIAN WITHOUT CONSENT OF CUSTODIAL PARENT

- 1. Enter your name and the name of the child(ren).
- 2. Enter the minor child(ren)'s address.
- 3. Enter your mailing address, telephone number and email address.
- 4. Enter the name of the custodial parent of the child(ren).
- 5. Check one of the boxes to indicate whether the whereabouts of the custodial parent are known or unknown. If the whereabouts of the custodial parent are known, complete the address, telephone number and email address.

- 6. Enter the name of the non-custodial parent.
- 7. Check one of the boxes to indicate whether the whereabouts of the non-custodial parent are known or unknown. If the whereabouts of the non-custodial parent are known, complete the address, telephone number and email address.
- 8. Check the box to indicate if the non-custodial parent's rights have been terminated by Court Order.
- 9. Check the box to indicate whether you have notified the non-custodial parent of your intent to petition the Court for temporary guardianship.
- 10. List the steps you have taken to notify the non-custodial parent about the filing of this petition.
- 11. Check the box to indicate your relationship to the minor child(ren).
- 12. Check one of the boxes and list the docket number associated with either the custody action or dependency action. If there is not a custody or dependency case involving the minor child(ren), check the third box.
- 13. There is nothing to complete. You aver that your rights and responsibilities as a temporary guardian toward the minor child(ren) will become effective upon the completion of a hearing and rendering of a decision by the Court.
- 14. There is nothing to complete. You aver that you understand that your authority to act as a temporary guardian does not revoke the parental rights of the minor child(ren)'s parents and does not give you any parental rights.
- 15. Under section (b), enter your name and the name of the minor child(ren).

Sign the petition and print your name.
