Grantee's Project consists generally of providing evidence-based counseling to individuals diagnosed with Opioid Use Disorder (OUD) within the Medication Assisted Treatment (MAT) population at Dauphin County Prison. Clinical Supervisor (Shared resource), Counselor 1, Counselor 2 (Shared resource), Support Staff (Shared resource), Equipment (Laptops, printers, hot spots, office supplies), Client needs and supplies (Workbooks, notepads, pencils, handouts, etc.), Total cost not to exceed \$150,000.00 paid via 100% Opioid Remediation Grant Funding.
- 63. The Pennsylvania State University. Grantee's Project consists generally of the Penn State Health Vending Machine Initiative. Monthly maintenance fees, Vending machine items, User feedback, Project coordination effort. Total cost does not exceed \$75,000.00. Paid via 100% Opioid Remediation Grant Funding.
- 64. The Pennsylvania State University. Grantee's Project consists generally of the Penn State Health Maternal Use Disorder Clinic: Co-Investigator, Psychiatrist, Program/Project Manager, Educational Training, Facilities and Administrative costs. Total cost not to exceed \$150,000.00 via 100% Opioid Remediation Grant Funding.
- 65. Bethany Christian Services of Central Pennsylvania, Inc. Grantee's Project consists generally of the expansion of the ReNew program: Personnel, Benefits, Staff Travel, Occupancy, Supplies and Operating Expenses, Indirect costs. Total cost does not exceed \$150,000.00 via 100% Opioid Remediation Grant Funding.
- 66. Dauphin County Prison. Grantee's Project consists generally of hiring an Opioid Use Disorder (OUD) Grant Manager to oversee Dauphin County Prison's grant projects related to the administration of Medication Assisted Treatment, Salary and Benefits. Total cost not to exceed \$98,467.00 paid via 100% Opioid Remediation Grant Funding.
- 67. Dauphin County Prison. Medication Assisted Treatment Program.
 Grantee's Project consists generally of increasing Medication Assisted
 Treatment (MAT) services and supports for incarcerated individuals who
 enter the prison on an existing Medication Assisted Treatment and
 require continuation; Sublocade, Methadone, Buprenorphine,

- Buprenorphine, Subutex film, Buprenorphine Naloxone. Total cost not to exceed \$100,000.00 paid via 100% Opioid Remediation Grant Funding.
- 68. Elevyst, LLC. Grantee's Project consists generally of an Opioid Use Disorder (OUD) and Harm Reduction Training to equip First Responders, Corrections Officers, and Treatment Professionals with the knowledge and skills to better identify, interact with, and assist those affected by the overdose crisis; Training staff, Program development and design, Networking launches, Training materials for participants. Total cost does not exceed \$30,000.00 by 100% Opioid Remediation Grant Funding.

State Opioid Response Agreements

Funding Source: Pennsylvania Department of Drug and Alcohol Programs (DDAP)Program: State Opioid Response (SOR) Housing program.
- 71. Daystar Center for Spiritual Recovery, Inc. The SOR Housing program provides rental assistance for people diagnosed with opioid use disorder and/or stimulant use disorder. At a rate of seven hundred sixty dollars (\$760.00) per month per resident's approved SOR application for a maximum of three months of rental assistance per resident. Funding Source: Pennsylvania Department of Drug and Alcohol Programs (DDAP)Program: State Opioid Response (SOR) Housing program.
- 72. Steps of Active Recovery, Inc. The SOR Housing program provides rental assistance for people diagnosed with opioid use disorder and/or stimulant use disorder. - 73. Herkey Houses, Inc. The SOR Housing program provides rental assistance for people diagnosed with opioid use disorder and/or stimulant use disorder. At a rate of seven hundred sixty dollars (\$760.00) per month per resident's approved SOR application for a maximum of three months of rental assistance per resident. Funding Source: Pennsylvania Department of Drug and Alcohol Programs (DDAP)Program: State Opioid Response (SOR) Housing program.
- 74. TKO Rental Properties, LLC. The SOR Housing program provides rental assistance for people diagnosed with opioid use disorder and/or stimulant use disorder. At a rate of seven hundred sixty dollars (\$760.00) per month per resident's approved SOR application for a maximum of three months of rental assistance per resident. Funding Source: Pennsylvania Department of Drug and Alcohol Programs (DDAP)Program: State Opioid Response (SOR) Housing program.

COMMISSIONERS' DISCUSSION & ACTIONS

Mr. Hartwick talked about a coordinated response that came from CCAP conference on how to do their job as government officials. The financial impacts that are happening to countries across this commonwealth to school districts that are beginning to process of opening that are not being funded and the weight that is being put on the county. The County will have to float Children and Youth, Drug & Alcohol operations, along with

mental health operations, area agency on aging operations. This will have a significant impact. The Counties will have to carry the load.

Mr. Pries thanked Mary Bateman for her time as Chair of the Prison Board. Our Parks & Recreation Jazz and Wine Festival is coming up on September 6th and 7th. I thought the Board agreed to RFP everything. Where are we on that? Eric Hagarty- will update the Commissioners soon.

Mr. Douglas agrees with Commissioner Hartwick's statements on the CCAP letter, without a budget the cost is shifted to us. Many counties are taking out loans to cover the cost of their department, when that happens, interest grows and the state doesn't cover that, so that cost is shifted to the taxpayer. PA is one of only two states that do not fund public defenders' offices. We really need the state to pass the budget. LinkedIn ranked Harrisburg #3 in its top 25 fastest growing US metro areas for jobs and new talent. He ran the Wildwood 5K this past weekend and it was a great event! Brandon Flood's passing, he was a great person when it comes to helping people with incarceration and helping with reentry into the world. He made a massive impact to the area. He will be greatly missed.
