Allen Proper, “Props”, started his career with Dauphin County Adult Probation (APO) on April 28, 2014. Prior to that he was a Correctional Officer with Lancaster County Prison. During his time at APO, Allen was a union steward where he worked to provide a positive work environment for his peers.

Allen was admired by everyone that met him. His infectious smile lit up the room and he was well respected by all staff and the offenders that he supervised. He had multiple letters from his offenders hanging on his bulletin board thanking him for the job that he did, which are still there today. Even after arresting an offender, it was common for them to thank him for treating them so well and for doing his job to the fullest.



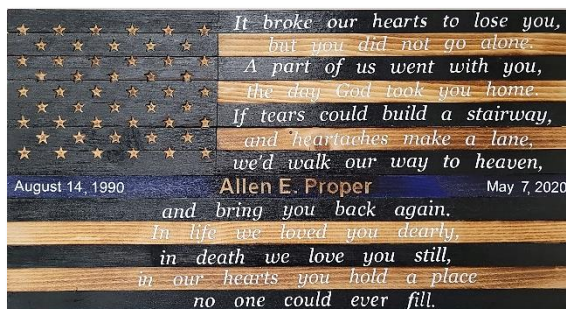
Allen also became an ordained minister, where he officiated two APO weddings. His jokes were memorable, and he was always considered the life of the party. Everyone that came in contact with him has a story about his generosity, his willingness to help with whatever was asked and his competence in his job. If there was a model for what the ideal Officer would look like, his name would be Allen Proper. Not just because of his stunning good looks, but because he really embodied those ideals and concepts, not only making him a great probation officer, but an amazing human being.

Allen was the guy you immediately went to when you needed help. He was always willing to lend a helping hand, inside or outside of work. He truly was a dependable rock that you could count on. He would drop anything on a moment's notice to help you. Not only was he more than willing to help, but he would also give it his full effort and stay until the job was done.

Allen was a man that you could confidently confide in. You could trust him as your friend to speak to on any topic, and to receive an honest answer in return. He was a loyal friend to everyone. He would take your concerns seriously, but always had a way to lighten the mood and make you laugh. Allen really had a way of making you laugh. Allen touched all of us through his friendship, his generosity, his kindness, and his laughter. He really was a friend to nearly everyone he met.



Sadly, his life came to an end on May 7, 2020 after succumbing to injuries received in a motorcycle accident. Even in his death, Allen continued to help others by donating his organs to 14 recipients through the Gift of Life Program. Through this act, he was able to touch the lives of even more people. Allen saved the lives of people through this sacrifice. John 15:13 says “Greater love hath no man than this, that a man lay down his life for his friends”. Allen truly was a friend to all.



On May 9, 2020, members from the Dauphin County Probation Department, PA State Police, Steelton Police, Dauphin County Sheriff's Department, Harrisburg City Police, Derry Township Police, along with many family and friends, transported Allen from the Geisinger Medical Center, Danville, to the funeral home in New Cumberland. A police escort was held over the 70 mile trip with multiple police departments jumping in as we drove through their jurisdictions.

There were people stationed along the route with signs and banners and every overpass that we went under was lined with police, fire fighters and EMS personnel. Upon arriving at the funeral home, over 300 people were in attendance, lining the street. It was definitely a day that everyone will remember. On top of this memorable day, ABC 27 News contributed a news piece that evening to show just how amazing the escort really was.

Since this tragic event, our office has participated in many events to honor and remember Allen's life.

On May 11, 2020 at 4:01pm, with all radios turned on, we were able to hear the last radio transmission for 66156.

On Friday, August 7, 2020, there was a Celebration of Life at Whispering Pines Estates in Lewisberry. Over 200 people were in attendance and came together to share stories, laugh and cry. We all had a great dinner and a time of remembrance, as well as an encouraging service to honor Allen.



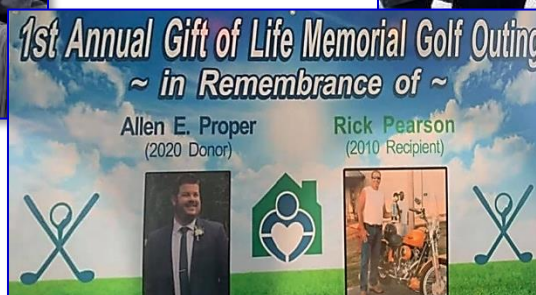
On August 14, 2020, to honor Allen on what would have been his 30th birthday, Probation Services held a luncheon with the help of Mission BBQ, so his family, co-workers and friends could gather and remember our beloved friend on the day he was born. There is a tree, a bench and a plaque dedicated to Allen at the Adult Probation Office where anyone can stop and have a moment in the "Allen Garden".



On April 3, 2021, a Back the Blue 5k in honor of Allen was held at City Island. Participants all wore "Back the Blue" shirts and could either choose to run the 5k or have a leisurely walk. Many participants brought their family and their dogs (which Allen would have loved) to the event. Refreshments were provided by Allen's family.

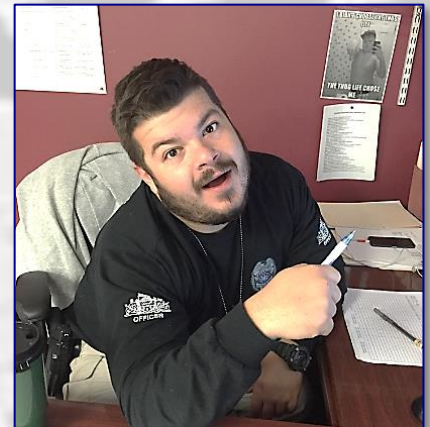

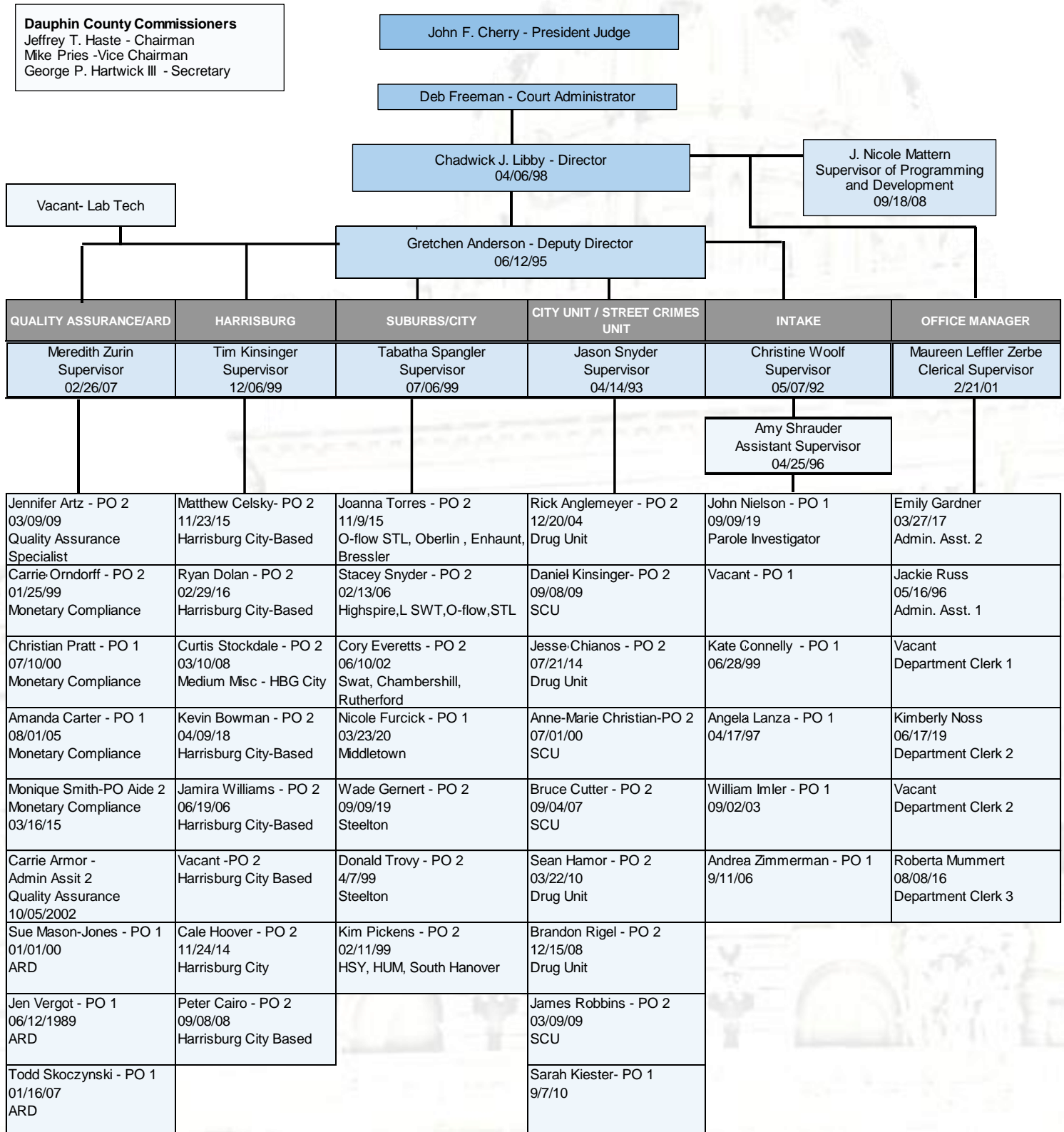

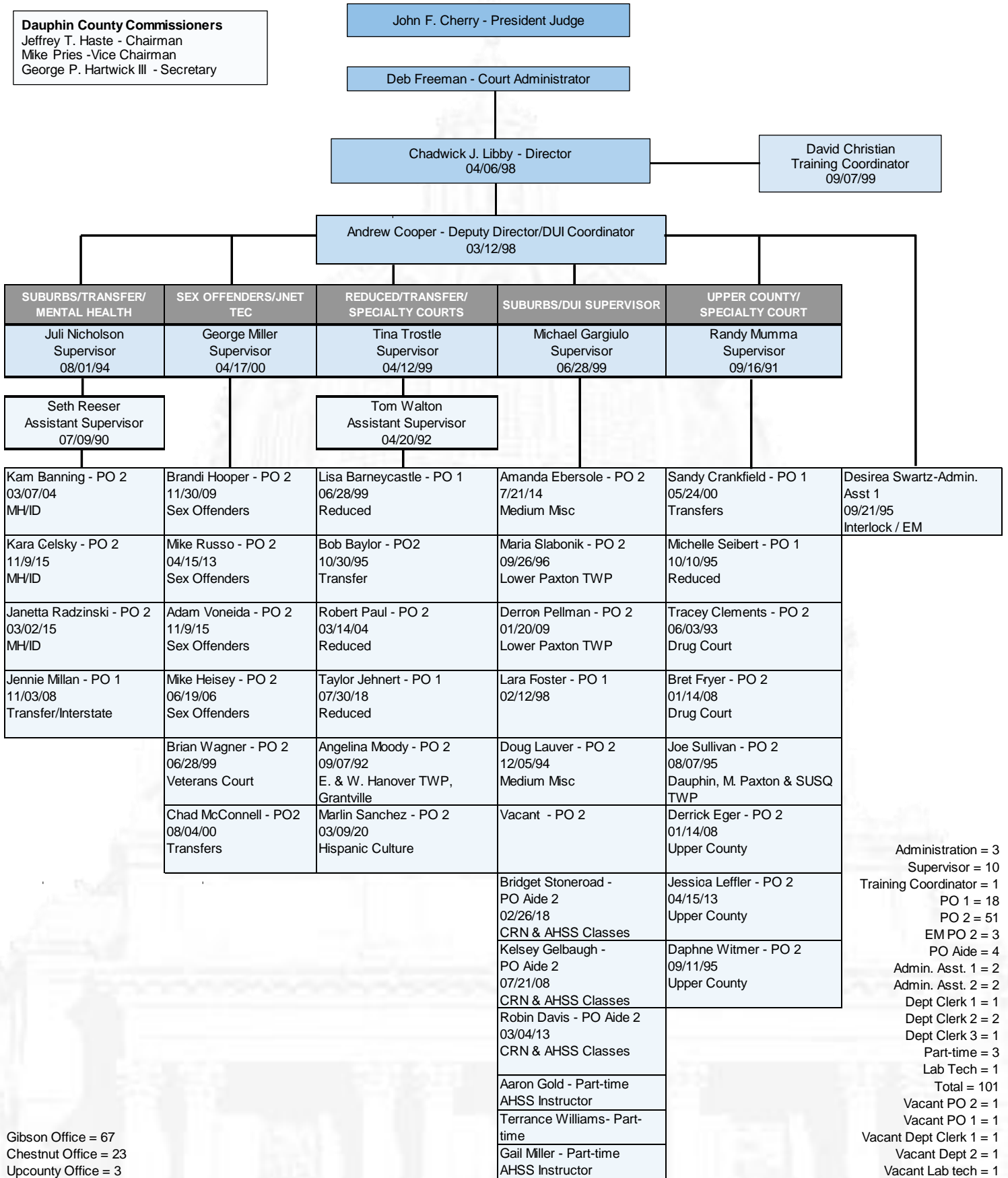
Adult Division Organizational Chart

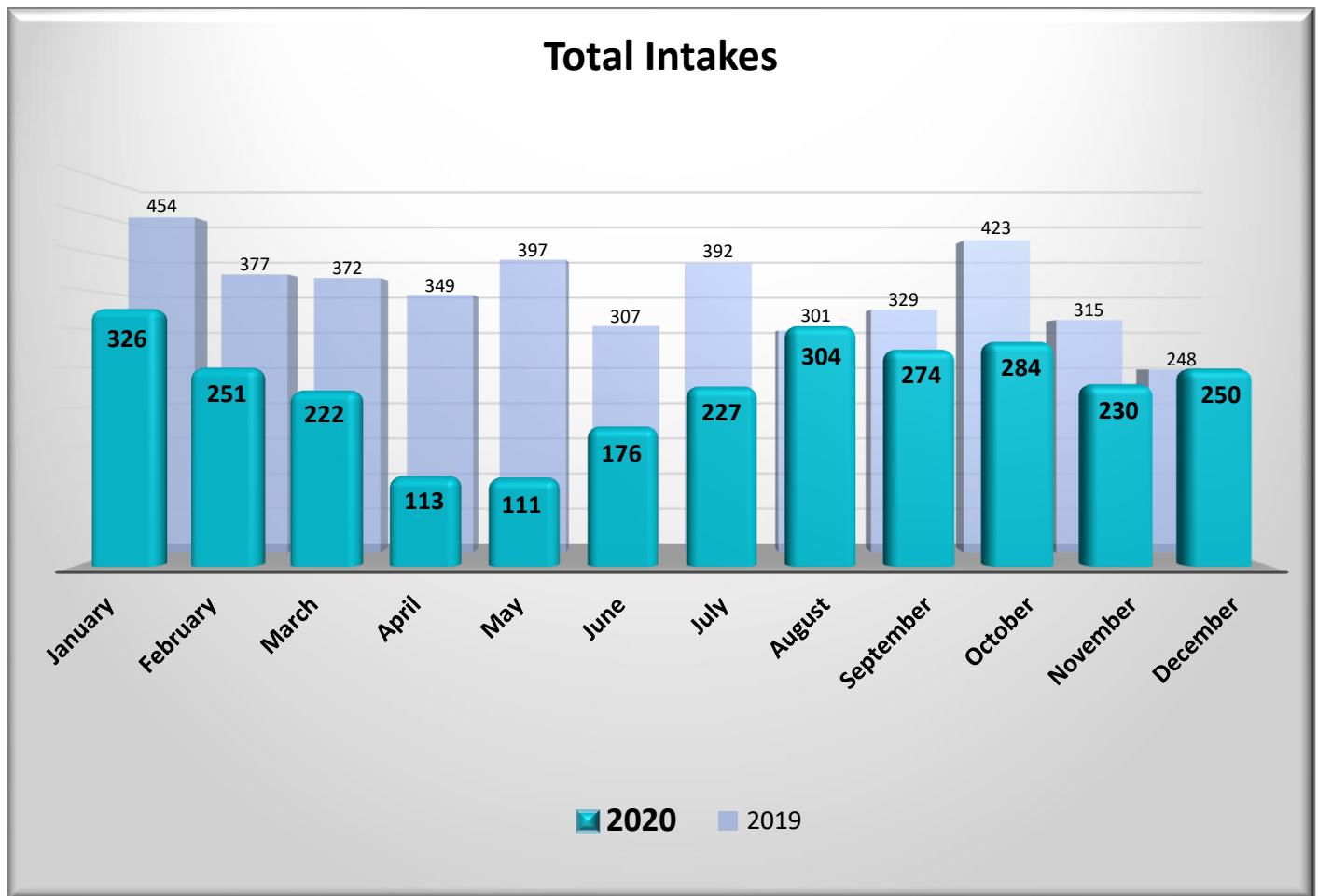

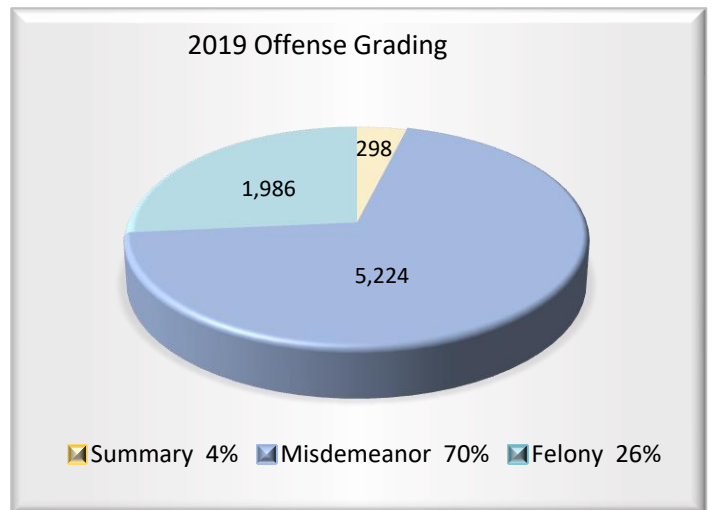
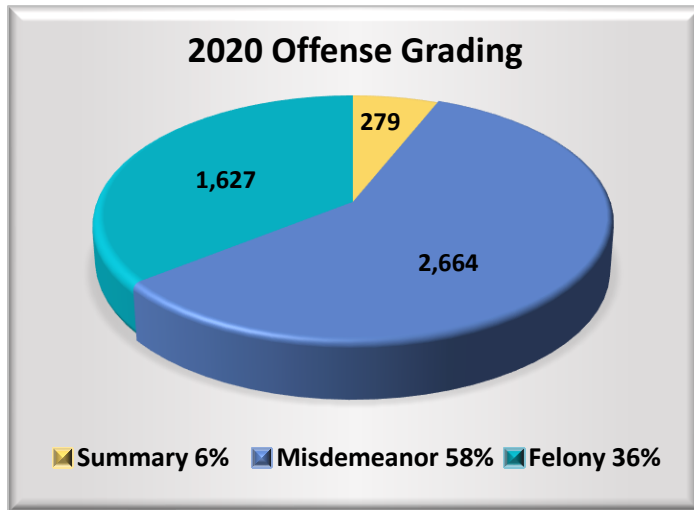
The Intake Unit within the Adult Division of Dauphin County Probation Services is made up of 7 officers. In addition to documenting the offenders' sentences, gathering personal information, and reviewing the rules of supervision, these officers also carry out the initial step in the Ohio Risk/Need Assessment (ORAS) process by completing pre-screeners on designated individuals. This is done to assist in determining what unit the offender will be assigned to and if further evaluation will need to be conducted.

The following is a synopsis of the 2,768 offenders who were processed through the Intake Unit in 2020. This is a 35% decrease from 2019, in which they completed a total of 4,264 intakes.



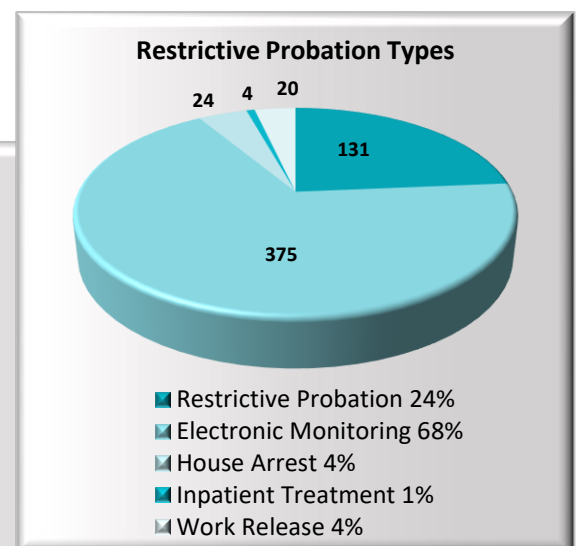
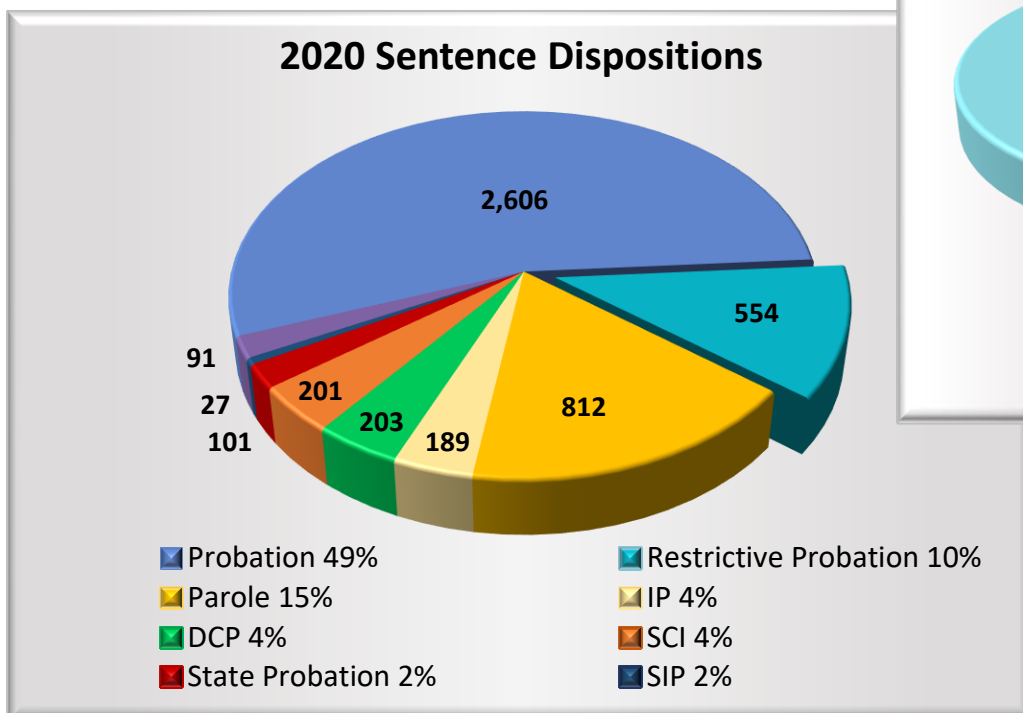
Offense Grading

Of the 2,768 intakes, there were 4,750 offenses recorded. Summaries accounted for 279 (6%), 2,664 (58%) were *Misdemeanor* offenses and 1,627 (36%) included *Felonies*.

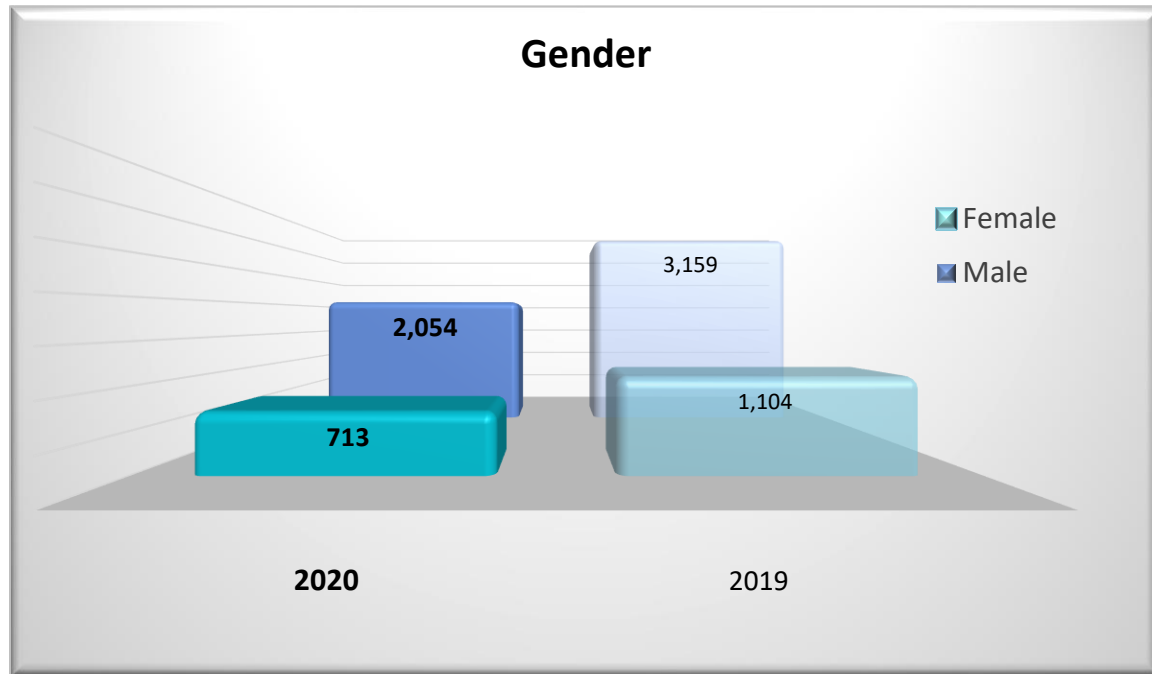


Dispositions

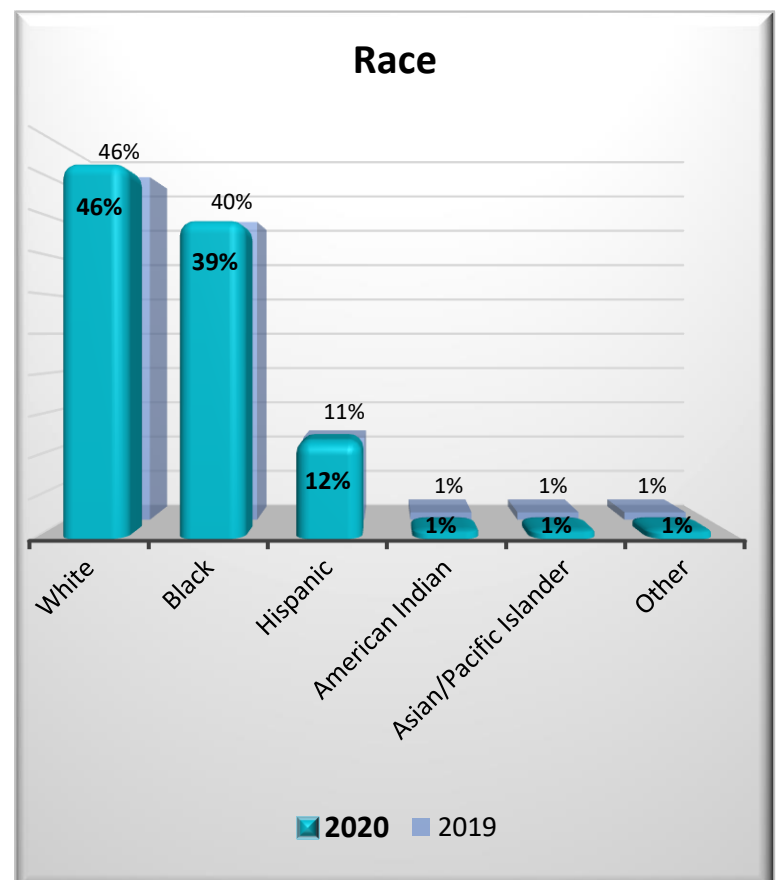
Of the 2,768 intakes in 2020, there were 4,784 sentence dispositions including probation, restrictive probation, parole, intermediate punishment (IP), Dauphin County Prison (DCP), state correctional institutions (SCI), state probation, State Intermediate Punishment (SIP) or requests for special probation/parole supervision by the state, known as a 325.



In 2020, of the 2,768 intakes completed, 2,054 (74%) were male and 713 (26%) were female, compared to 2019 when 3,159 (74%) were male and 1,104 (26%) were female.

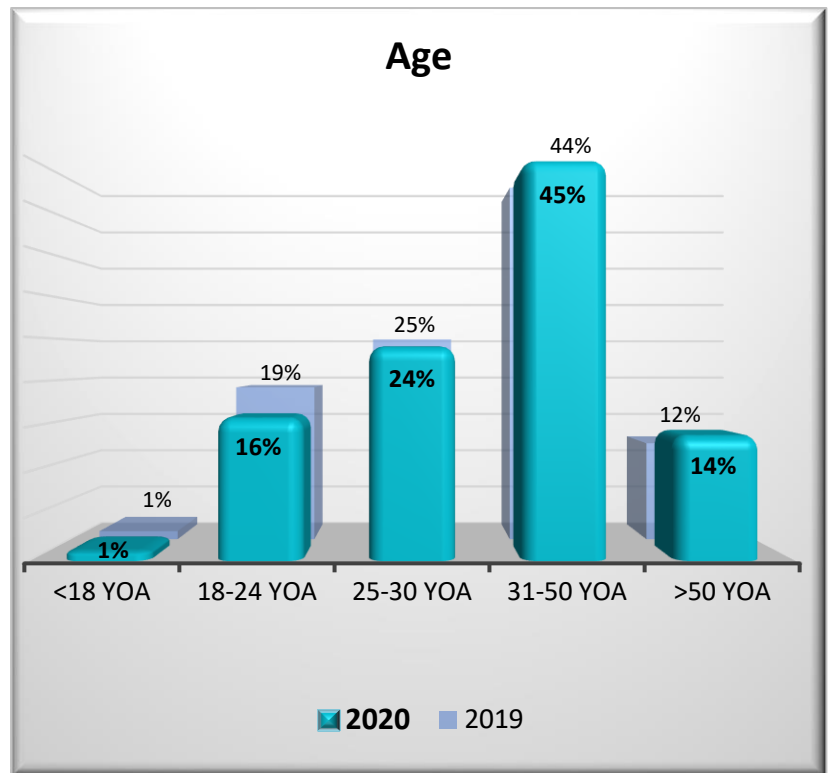

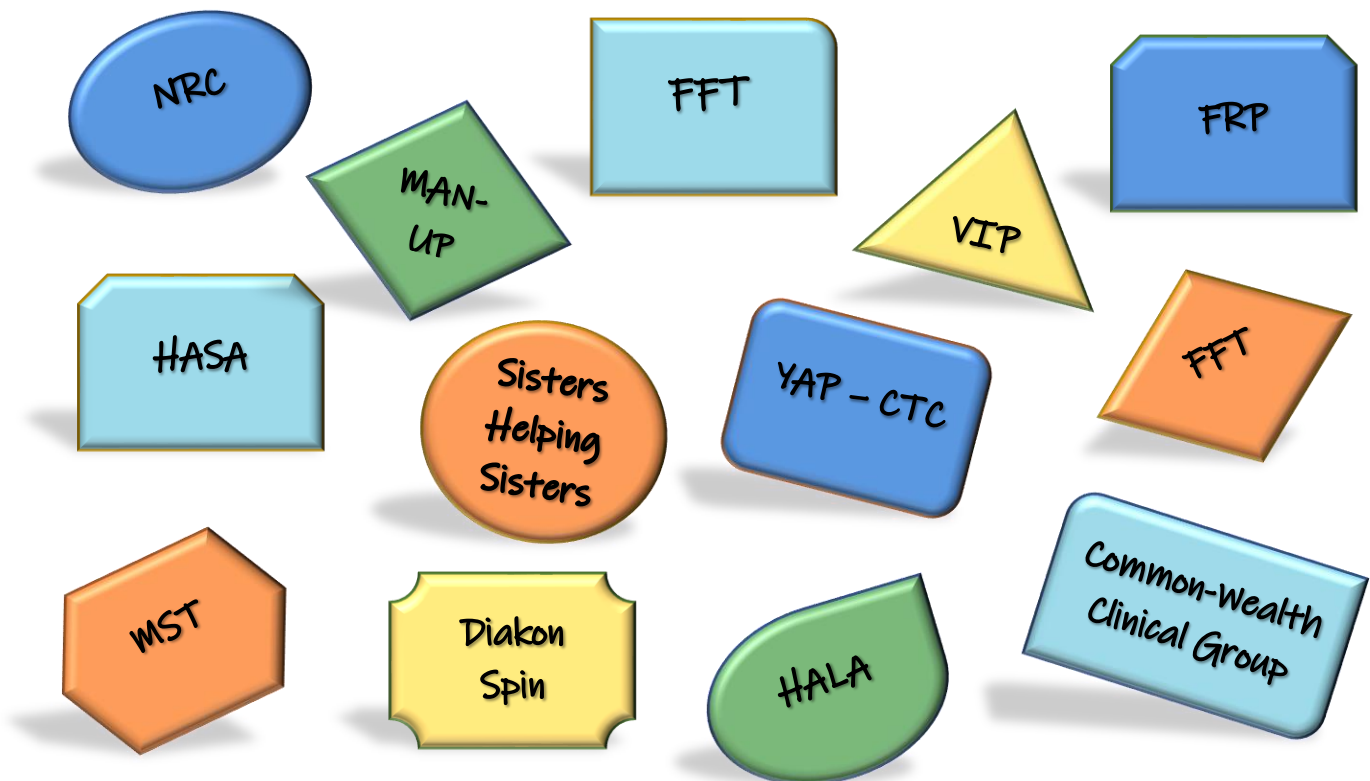


Community Provider Shouts-Outs

Recognizing the Electronic Monitoring Unit

At the onset of the COVID 19 pandemic, many traditional duties and responsibilities of probation officers had to be altered in an effort to minimize risk and exposure to the virus. Fieldwork was suspended, contacts with offenders were made via Facetime and Windstream meetings for court hearings are just a few examples of adjustments that had to be made. There was one unit, however, whose essential duties and responsibilities were not able to be altered. From the onset of the pandemic, the essential duties and responsibilities of the Electronic Monitoring (EM) Unit carried on. It is also important to note that the EM unit serves both the Adult and Juvenile Division of the Dauphin County Probation Services Department as well as Dauphin County Pretrial Services. Prior to the pandemic, on any given day there were over 400 offenders on some type of electronic monitoring (GPS or alcohol monitoring). With that said, protocols needed to be developed and put in place to allow for these duties to continue while again, minimizing risk and exposure to the virus at the same time.

Offenders who were court ordered onto EM could not have their devices installed virtually. As was before COVID, they were required to report to the Probation Services Office to have their unit installed. EM officers rotated office days daily and were responsible for installing devices on those offenders ordered onto the program. COVID questions were asked, temperatures taken, and all necessary PPE worn, however, these officers were frequently required to be in close proximity to offenders who could potentially be carrying the virus. There were also offenders who were required to report to the Probation Services Department to have data downloaded from their device, including offenders being released from prison or detention. Consequently, while the prison population was being reduced, the number of offenders being placed on EM was increasing. As COVID struck the prison, there was constant communication with prison officials regarding those being released in order to not put EM officers in harm's way of the virus. Those released from certain blocks where quarantining was taking place were instructed to report to the Probation Services Department for installation at the completion of their quarantine.

We would like to recognize and thank the Electronic Monitoring Unit of the Dauphin County Probation Services Department. Under the leadership of Supervisor **John Christman** (20 years of service), the EM Unit managed the virus daily and was able to discharge their duties as directed by the Court in a safe manner. This was only able to be done through constant focus and effective communication between all unit members. Unit members **Larry Muza** (25 years of service), **Troy Smith** (21 years of service), **Fred Grove** (21 years of service), **Brandon Bellinger** (19 years of service), **Aaron Harvey** (17 years of service), **Chris Carter** (10 years of service) and **Tanya Zinn** (6 years of service) put their trust in one another to follow established COVID protocols and look out for one another. Thank you all again for your efforts and professionalism displayed during the entire pandemic!!
