Parties are required to attend the Seminar for Parents in Conflict and Change if they have not attended the Seminar within the past 12 months and are involved in the following types of cases:

- Custody Case
- Divorce case where the parties are the parents to a child(ren) under the age of 18
- Child support case where an appeal has been filed

The Court will entertain a Motion to Waive Seminar Attendance in certain situations where attendance is a hardship or the moving parent in a divorce has attended but the other parent has not and the entry of a divorce decree is on hold for this reason.

This form should not be filed just because the parent does not want to attend the Seminar. There must be a very good reason for the Court to excuse this requirement.

• Complete the name of the case as it appears on other filings and fill in the docket number.

• Complete the Distribution section by writing your name and address and the name(s) and address(es) for all attorneys or self-represented parties.

If this is a custody, divorce, or support case, you are a victim of abuse and the other party is the abuser and you do not want the other party to know your contact information, write "See CIF Abuse Victim Addendum" and complete the Confidential Information Form (CIF) Abuse Victim Addendum. This form is to be filed with the Prothonotary or the Domestic Relations Office and should not be sent to the other party(ies). This contact information will only be available to the Court and Court staff. If you print out the Motion to Waive Seminar Requirement in Custody, Divorce or Support Cases packet from the Self Help Center page of the Dauphin County website, the Confidential Information Form Abuse Victim Addendum is not included. You must print out this form in accordance with the instructions appearing on the webpage.


