Sheriff Fees

Civil Process Sheriff Fees

The following are the Sheriff Fee's for Civil Process. Please feel free to contact our office with any questions or for clarification.

No personal checks are accepted.

Writ of Execution and Writ of Possession – To include personal property levy, liquor license, bank garnishments and evictions - **\$300.00 deposit**

Property Claim and Claim for Exemption - \$55.00

Writ of Execution Real Estate – Sheriff Sale of Real Property - **\$2,500.00 deposit**

PFA (Protection from Abuse) – No fee

Civil Process – To include all other civil process filed in and outside of Dauphin County, please refer to the information provided below.

Filed in Dauphin County

Base Rate - **\$51.00**

Each Additional Defendant - **\$30.00**

Deputization to another county - **\$9.00 per county**

Filed outside of Dauphin County

Base Rate - **\$30.25**

Each Additional Defendant - **\$19.25**

****Mileage Costs** – add mileage listed on next page for each separate zone, regardless of how many defendants will be served in that zone

Example: Filed in Philadelphia County with 4 defendants being served in Dauphin County, add \$30.25, \$19.25, \$19.25, \$19.25 and mileage

Example: Filed in Dauphin County with 3 services total; 1 being served in Dauphin County, 2 being deputized to 2 counties, add \$51.00, \$30.00, \$30.00, \$9.00, \$9.00 and mileage

Therefore, if there are 4 services in the same zone, only add mileage 1 time. If there are 3 different zones, add mileage for all 3 zones.

Equation: (add only what is required)

$$\text{Base Rate} + \text{Additional defendants} + \text{mileage} + \text{deputization} = \text{Total Cost}$$

License to Carry Fees

License to Carry Firearms - \$20.00

If denied, a \$15.00 refund will be issued by check at a later date

Replacement Photo LTC Firearms - \$10.00

License to Sell Firearms - \$30.00

Precious Metals License - \$50.00

Domestic Relations Fees

Domestic Relations Transportation Fee - \$120.00

This fee gets paid to the Sheriff's Office when arrested and booked on outstanding Domestic Relations Warrant (child support)
