Municipalities where this occurs are identified by a letter after above basic municipal tax rate. They are H (Hydrant); L (Street Lights); S (Sewer); T (Trash), and may not be included in the above rate. Contact the Tax Collector or Municipal Office for more information on a particular property.

* School Real Estate Tax Millage Rates are 2026/2027 Fiscal Millage Rates from July of 2026.
